oda Kotb is the co-anchor of NBC News' TODAY and co-host of the fourth hour of NBC News' TODAY alongside Kathie Lee Gifford. Since joining NBC in 1998, Ms. Kotb has served as a correspondent for Dateline, where she has covered a wide variety of domestic, international, and human-interest stories and features, including Hurricane Katrina, the war in Iraq, the conflict in the West Bank and Gaza, the War on Terror in Afghanistan, and the 2018, 2016 and 2012 Olympics.

A New York Times bestselling author, Hoda Kotb has written four books: I've Loved You Since Forever; Hoda: How I Survived War Zones, Bad Hair, Cancer and Kathie Lee; Ten Years Later: Six People Who Faced Adversity and Transformed Their Lives; and Where We Belong, which was released in January 2016. Ms. Kotb is a nine-year breast cancer survivor and is involved in several initiatives to raise awareness about the disease.

In 2016, Ms. Kotb was recognized with a Gracie Award for *The Hoda Show* on SiriusXM. She received both a Gracie Award and a Webby Award in 2015, for her *Truly Brave* music video about pediatric cancer. She received additional Gracie awards in 2008 and 2003, the Alfred I. duPont—Columbia University Award in 2008, a Peabody Award in 2006 for her report *The Education of Ms. Groves*, and a 2002 Edward R. Murrow Award. Ms. Kotb was awarded Daytime Emmys in 2010, 2011, and 2012, as part of *TODAY*'s recognition as the best morning news program.

Prior to joining NBC News, Ms. Kotb worked as an anchor and reporter at WWL-TV in New Orleans (1992-1998) and WINK-TV in Fort Myers, Florida (1989-1991).

Ms. Kotb graduated from Virginia Tech University with a Bachelor of Arts in broadcast journalism. She welcomed daughter Haley Joy in February 2017 and resides in New York City.

She also appears among Fortune's "50 Most Powerful Women," Forbes' list of "The World's 100 Most Powerful Women" and Vanity Fair's "New Establishment' list.

Ms. Hammer has a long history of commitment to social issues and recently relaunched her Emmy awardwinning social impact campaign Erase The Hate. The campaign has been reinvented for today's world to encourage a new generation to take action against hate. intolerance and inequality in America.

Ms. Hammer is the recipient of numerous honors and awards including: UJA Federation of New York's Steven I. Ross Humanitarian Award: New York Women in Communications' Matrix Award: Women in Film's Crystal+Lucy Award; the Anti-Defamation League's Entertainment Industry Award; and NATPE's Brandon Tartikoff Legacy Award.

Ms. Hammer serves on the Board of Directors of eBay and IAC/InteractiveCorp, and on the strategic planning committee for Boston University's College of Communication.

Ms. Hammer holds a bachelor's degree in communications and a master's degree in media and new technology from Boston University. She also received an honorary Doctorate of Humane Letters upon delivering the commencement address to Boston University's graduating class of 2017.

anuel De Jesus Figueroa, "Manny," is a high school senior on the autism spectrum. Manny arrived in New York City from Florida when he was in the 5th grade. Although Manny was mandated to receive speech, occupational, and physical therapies, he did not progress. He was taunted by his peers, misunderstood by his teachers, and neglected by an administration that did nothing to address mounting warning signs.

Manny's mother, Caroline Figueroa, has always believed in Manny's ability to succeed in school. Faced with Manny's school trauma and the Department of Education's (DOE's) inability to offer an appropriate program, she knew she had to take action. A DOE psychologist secretly told Ms. Figueroa to call AFC, and the tide started to turn for Manny.

AFC worked quickly, obtaining Manny's admission to the sixth grade at Gersh Academy, a private school for students on the autism spectrum, and won an impartial hearing awarding full tuition and compensatory services for Manny. The next year, Jon Cyprys, an attorney with

Greenberg Traurig, became pro bono co-counsel. Jon has worked with AFC to represent Manny's interests, securing tuition for the past six years, including funding for meal reimbursements.

Throughout his academic career—despite living in temporary housing, illness in his family, and stresses of the unknown—Manny has persevered and blossomed in his education. This month, Manny will graduate with a Regents diploma and is off to Hostos Community College, where he will study digital design and animation. 

these partners build their capacity to advocate for the educational needs of the children they serve.

ADVOCATES FOR CHILDREN AT A GLANCE

By Understanding and Addressing the Education-Related Challenges Confronting the City's Most Vulnerable Children:

AFC proudly serves on the frontlines of the fight to champion the education-related rights of children and youth who are most likely to experience failure or discrimination in school because of factors beyond their control.



CHILDREN WITH DISABILITIES

AFC's multi-pronged approach is a model for education advocacy throughout the city and state. First, we provide one-on-one legal representation and advocacy to help low-income families of children with disabilities get the educational services and support they need. Second, we offer free workshops throughout the city to bring training, information, and direct assistance on the education system to parents and the

professionals who work with them. Third, we address systemic problems with the education of students with disabilities through our policy work and when necessary, federal litigation. And finally, we coordinate and lead a collaborative effort called the ARISE Coalition, which brings together more than sixty different organizations and individuals to press for policy change to benefit children with disabilities in the New York City schools.



IMMIGRANT STUDENTS & FNGIISH LANGUAGE LEARNERS

AFC's bilingual project staff advocates on behalf of individual parents and their children, trains parents and community-based organizations serving immigrant families on education-related rights, monitors access to interpreters and translated materials in the city's schools, and collaborates with other groups to support communities seeking to improve outcomes for immigrants and English Language Learners.

EARLY CHILDHOOD

AFC's Early Childhood Education Project provides individual case assistance, community education, and policy advocacy to improve access to early childhood education for low-income children, ages 0-5, so that children can enter kindergarten prepared to succeed.

CHILDREN IN THE CHILD WELFARE SYSTEM

AFC's Project Achieve advocates for the educational needs of children in or at risk of placement in foster care while building capacity in the agencies that serve them. Project staff operates satellite offices in child welfare agencies, providing on-site assistance and training to caseworkers, birth parents, and foster parents so that

they can address the education-related issues affecting their children. Project staff also conducts policy advocacy on the city and state levels to improve educational outcomes for students in foster care.

STUDENTS FACING DISCIPLINARY ISSUES & COURT-INVOLVED YOUTH

AFC's School Justice Project (SJP) provides case advocacy and legal representation to address the educational needs of youth facing school suspension or court involvement. Through relationships built with social services agencies, community-based organizations, and community courts,

project staff are able to reach the students who often fall through the cracks. The project also provides trainings and technical assistance to parents, young people, and the professionals who work with them. Finally, project staff advocate for systemic reform with respect to school discipline and school climate, as well as the education of court-involved youth.

STUDENTS IN TEMPORARY HOUSING

AFC operates the New York State Technical and Education Assistance Center for Homeless Students (NYS-TEACHS), which focuses on building the capacity of school districts throughout the state to improve educational opportunities for homeless children and youth.
