Dear Senator Schumer and Senator Gillibrand:

On behalf of Advocates for Children of New York (AFC), we urge you to oppose the confirmation of Betsy DeVos as the next United States Secretary of Education. We are deeply troubled by Ms. DeVos's lack of experience with public education and her record of advocating to steer funding to private school vouchers instead of strengthening the public schools that serve the vast majority of children in this nation.

For more than 40 years, AFC has worked to ensure a high-quality education for New York students who face barriers to academic success. We work on behalf of children who are at greatest risk for school-based discrimination or academic failure due to poverty, disability, race, ethnicity, immigrant or English Language Learner status, sexual orientation, gender identity, homelessness, or involvement in the foster care or juvenile justice systems.

There is no question that significant work is needed to improve education for these groups of students. We believe that addressing these barriers on the national level requires a leader with extensive public education experience and a rock-solid record of working to strengthen the public schools that these students attend. Regrettably, Ms. DeVos lacks these qualifications. Ms. DeVos's education efforts have focused on advocating to divert funding from public schools to private school vouchers and tax credits and opposing oversight and accountability of publicly funded charter schools. In our experience, the federal government has helped strengthen education by allocating targeted funding to help public schools serve students from low-income
