Re: Coalition urges immediate action on June 2022 Regents Exam exemptions

Dear Commissioner Rosa, Chancellor Young, and Members of the Board of Regents:

On behalf of the of the Coalition for Multiple Pathways to a Diploma, we are writing to thank you for your recent vote to allow students to graduate without January 2022 Regents exams and to urge you to act quickly to extend these exemptions to include June 2022 Regents exams.

Students preparing to graduate this June have had their last three years of high school dramatically impacted by the COVID-19 pandemic. Our coalition of more than 80 parents, educators and advocacy organizations are extremely concerned about the social and emotional toll this pandemic has taken on students and teachers. For better or worse, we have all learned much from this pandemic: about the actual needs of our youth and families, about the kind of learning that will prepare students for the world ahead, and about where educators' energies can most help young people through difficult times. It is evident to us that the Regents exams are not the most effective gauge of this learning.

Your swift action to decouple June 2022 Regents exams from graduation would enable students and teachers to focus valuable planning and instructional time on learning that is most essential for youth and families, rather than preparing for high-stakes tests in the midst of staffing shortages, temporary shifts to remote learning, and the intense anxiety and isolation brought on by this terrible pandemic. Such action would also bring New York into step with the vast majority of states that use ESSA accountability assessments to measure schools but not to determine individual students' readiness for graduation.

We appreciate that determining whether to *administer* June 2022 exams is more complicated -requiring Federal approval in some cases -- and that a final decision in the matter may be
months away. However, we ask that NYSED and the Board take action at the February Regents'
meetings to waive these exams as *individual students' graduation requirements* and, instead,
allow students to graduate if they have met their coursework requirements for those classes.
Our proposed action is squarely within the Board's authority, as neither New York's ESSA plan
nor ESSA itself require that accountability assessments be tied to graduation. Acting quickly to
authorize June 2022 Regents Exam exemptions would allow students, teachers and other

school staff to plan for the remainder of the school year and would free up instructional time to utilize more innovative, authentic measures of student mastery.
