### Advocates for Children of New York

Since 1971, Advocates for Children of New York (AFC) has continued to play an important and unique role in New York City's public education system. The organization focuses on children and youth most likely to struggle or experience discrimination in school because of poverty, race, disability, immigration status, language barriers, homelessness, or involvement in the foster care or juvenile justice systems. No other citywide organization provides these educationally vulnerable students and their families with necessary one-on-one guidance and advocacy while simultaneously pressing for systemic reforms that benefit all students. AFC's individual and policy efforts inform and strengthen each other, increasing its effectiveness in the communities it serves.

AFC serves children and youth, from birth through age 26, in all five boroughs of New York City. In an average year, 15,000 individuals receive one-on-one advice, case representation, or information and training that prepares them to advocate for themselves. Thousands more benefit from policies changed by AFC's advocacy.

Any parent of a New York City public school student knows that a school system of roughly one million students can be difficult to navigate. AFC operates the Jill Chaifetz Education Helpline, a citywide resource for parents who need information to help their children succeed in school. The Helpline responds to more than 4,000 calls a year from New York parents having problems with special education, transportation, school suspensions, transfers, and more.

Over the years, AFC has reached some of the most isolated students through collaborations with other organizations. For example, Robin Hood funds AFC to partner with 21 different organizations fighting poverty in areas such as child welfare, juvenile justice, and domestic violence. AFC staff trains the partners' staffs on education-related issues and provides intensive case advocacy and legal representation on education matters to the families they serve.

In addition, AFC has a number of projects focusing on particular populations:

- Children with Disabilities
- Immigrant Students and English Language Learners
- Children in the Child Welfare System
- Court-Involved Youth
- Children who are Homeless

## **Junior Board**

Founded in 2005, Advocates for Children of New York's Junior Board supports and promotes the organization's mission, helps expand awareness of AFC's programs, and draws attention to issues affecting the communities it serves.

Membership on the Junior Board gives young professionals the opportunity to develop leadership skills in a philanthropic environment and to advance their talents through challenging volunteer assignments. Members also acquire new business and personal contacts as they reach out on behalf of the organization.

#### Mission

The Junior Board's mission is to strengthen AFC's work by promoting its positions and accomplishments in the public arena, securing organizational and individual financial resources through fundraising activities, and contributing the professional talents and skills of its members.

Junior Board Members:

- Support AFC's mission to ensure a high-quality education for New York students who
  face barriers to academic success, focusing on students from low-income backgrounds.
- Raise the organization's visibility.
- Connect the organization to resources both financial and in-kind.
- Participate in fundraising projects and programs.
- Educate the general public about the organization, its projects, and its staff.

### Goals and Expectations

The Junior Board expects its members to use their individual creativity and skills to help develop AFC and contribute toward its continued strength. Membership requirements include:

- Attending quarterly meetings
- Participating in at least one Junior Board committee (Communications, Development, Membership)
- Giving or obtaining an annual contribution of at least \$350 per fiscal year (July 1—June 30)
- Bringing a passion and interest in education and a dedication to AFC's mission
